Why FML Process?



When should First Off to be performed?

First run of a production process,

After any changes that could affect product accuracy.

Applicable circumstances could include:

- Part reentering the product line after a hiatus
- New manufacturing location
- Testing a new supplier
- Customer's request to guarantee they receive the accuracy they want from their parts.



Middle Off/ Patrol:


The process of taking precise measurements of parts coming off the line during the production on a constant interval of time subsequent to the First Off, till Last off, to monitor the conformity during the processes. The number of samples may be fewer than the First Off or Last Off.

Last Off:

The process of taking precise measurements of parts coming off the line at the end of production. These undergo comparison with the First Off reports for consistency. By ensuring the measurements are the same at the end, one can logically deduce every part in between meets the part's exacting specifications.

Benefits of Last Off Inspection

- Identifying the root cause of a nonconforming part.
- Verifying that any non-conformances are resolved.
- Establishing traceability.
- Increasing confidence in part conformity, especially in conjunction with the First Off & last Patrol.


